



## BIAMP INFOCOMM 2017 CONTEST OFFICIAL RULES

Biamp Systems Corporation (“Biamp”) is sponsoring the Biamp InfoComm 2017 contest (“Contest”) for InfoComm 2017. Eligible participants are subject to this Official Rules which includes the terms and conditions below, along with our [Privacy Policy](#), where applicable. PLEASE READ THE FOLLOWING TERMS. BY PARTICIPATING IN THE CONTEST, YOU ACCEPT AND AGREE TO ALL OF THE TERMS AND CONDITIONS SET FORTH HEREIN AND IN OUR PRIVACY POLICY. YOU HEREBY ACKNOWLEDGE THAT YOU ARE 18 YEARS OF AGE OR OLDER AND ELIGIBLE TO PARTICIPATE.

### Eligibility

The Biamp InfoComm 2017 contest is open those who are: (a) followers of Biamp (@Biamp) on Twitter and/or attending the InfoComm 2017; and (b) are legal residents of the United States who are eighteen (18) years or older at the time of entry. ### How to Enter, Winner Selection and Prizes

- 2.) During InfoComm (June 14-16 in Orlando, FL), visit Biamp booth 4043 and correctly answer the question of the day.

### INFOCOMM 2017

At InfoComm, from June 14-16, 2017, there will be one question per day at the Biamp booth (4043). The question of the day will be posted in the booth and promoted on Twitter. Show attendees must come to the booth and complete a short form with the correct answer to the question and their contact information. Each day the contest starts 9:00 am EST and ends at 2:30pm EST. Winners will be announced in the booth at 3:00pm EST each day of the show.

## Winner Notification
